## 2025 Legislative Session – March Update

This memo provides an update on legislative activities relating to the Lottery.

### Committee Approves Winner Anonymity and “Discounting” Bill

The House passed [HB 3115](#). As mentioned in previous updates, this bill would prohibit the sale or purchase of winning lottery tickets. The version passed by the House included [additional provisions](#) adopted in committee. As amended, the bill prohibits taxpayers from deducting the purchase price paid for a winning Lottery ticket from their Oregon income taxes. The bill also exempts the name and address of Lottery prize winners from disclosure under public records law. HB 3115 now moves to the Senate for consideration. ### Senate Passes Bill to Change Lottery Billboard Requirements

The Senate passed [SB 914](#). As mentioned in previous updates, this bill would require Lottery to include the problem gambling helpline on any billboard advertisements. An amendment was adopted to clarify that the requirement only applies to new billboards, and therefore, does not require Lottery to change current billboards. SB 914 now moves to the House for consideration.

The Lottery has no position on HB 3115 or SB 914 but we reported to the Legislature that we are prepared to implement the bills without any negative fiscal impact to Lottery.

### Lottery Invited to Present to Ways & Means

The General Government Subcommittee of Ways & Means invited Lottery to present an overview of Lottery’s operations, game portfolio, and financial management. Lottery Controller Karl Strauss will present to the subcommittee during the last week in March.

### Economic and Revenue Forecast Released

The state economist presented the latest economic and revenue forecast to state legislators. The forecast showed overall state revenue coming in above previous projections, although the forecast for Lottery revenue was adjusted slightly downward, projecting about \$1.9 billion in Lottery revenue for the 25-27 biennium. The final 25-27 state budget will be based on the June revenue forecast, which will be released May 14.

**Bills of Interest to the Lottery**

Lawmakers continue to break records with the number of bills introduced, with the current total above 3,300. As always, Lottery reviews the bills and tracks any that would impact the Lottery. See the attached bill tracker for the status of each bill Lottery is tracking.
