Subject:	Commission and Lottery Functions Under State Law

Background:

Lottery recently reviewed the state laws that govern the Lottery to identify the core functions of the Commission and Director. The table of the primary laws we reviewed is attached for your reference. This memo outlines our findings.

Overview of Core Functions of the Commission and the Director:

The Commission's core functions are to authorize games, adopt rules, set policy, and provide guidance and oversight to the Lottery and the Director. The Director's core function is to operate the Lottery "pursuant to the rules, and under the guidance of, the Commission." To facilitate coordination between the Commission and Director, state law requires the Commission and Director to meet "not less than monthly to make recommendations and set policy, to approve or reject reports of the Director, to adopt rules and to transact other business."

Delegated Authority:

Under ORS 461.130(1), the Commission may delegate any power granted to the Commission to an officer or employee of the Lottery. For example, in OAR 177-010-0025, the Commission authorized the Director to adopt internal operating policies and procedures, hire and oversee Lottery employees, and adopt temporary rules.

Functions Performed by the Lottery:

In documenting Commission and Lottery duties, we have identified some responsibilities that are assigned by statute to the Commission but that, over time, have been carried out by the Lottery on behalf of the Commission, subject to the Commission's oversight. Examples include:

- Prepare and provide financial reports and respond to requests for information¹.
- Engage an independent firm to conduct the biennial security review of the Lottery².
- Contract with the Oregon State Police for security services³.

- Separately account for and not intermingle certain types of game revenue and expenses⁴.
- Transfer a percentage of video lottery proceeds to the counties⁵.
- Implement a Responsible Gambling Code of Practice and operate the Lottery in compliance with the Code⁶.

This memo serves as documentation that Lottery will continue to carry out these duties on behalf of the Commission, subject to the Commission's guidance and oversight.
